MARKET REPORT

Stocks wobble, oil higher in major trading week

Oil prices were higher as OPEC and its allies prepare to meet Wednesday to discuss a further increase in output. Brent crude last week surpassed \$90 per barrel, a level last seen in October 2014. The price of West Texas Intermediate (WTI) crude hit its highest level in more than seven years earlier this month, fuelled by easing concerns about the Omicron Covid variant and geopolitical tensions.

HEADLINE CPI: The CPI calculates the cost to purchase a fixed basket of goods as a way of determining how much inflation is occurring in the broad economy. The CPI uses a base year and indexes current year prices based on the base year's values.

CORE CPI: The headline figure is not adjusted for seasonality or for the often volatile elements of food and energy prices, which are removed in the Core CPI.
