Southeast Asian equities shine as commodities rally on Ukraine crit Southeast Asian stocks are becoming a haven for international investors fleeing a worsening outlook for global equities who are hoping for sustained strength in the commodity-heavy economies of the region. The strong performance in Indonesian markets could bode well for equity listings, as its biggest tech firm, GoTo, looks to launch a domestic IPO that could raise at least \$1 billion in the first half, sources have said.

HEADLINE CPI: The CPI calculates the cost to purchase a fixed basket of goods as a way of determining how much inflation is occurring in the broad economy. The CPI uses a base year and indexes current year prices based on the base year's values.

CORE CPI: The headline figure is not adjusted for seasonality or for the often volatile elements of food and energy prices, which are removed in the Core CPI.
