Stock markets were lower on Wednesday as investors weighed the prospect of recession while inflation soars around the world. The yen fell to new lows against both the dollar and euro after the Bank of Japan - in contrast with other central banks - decided not to raise interest rates to rein in combat runaway consumer prices.

HEADLINE CPI: The CPI calculates the cost to purchase a fixed basket of goods as a way of determining how much inflation is occurring in the broad economy. The CPI uses a base year and indexes current year prices based on the base year's values.

CORE CPI: The headline figure is not adjusted for seasonality or for the often volatile elements of food and energy prices, which are removed in the Core CPI.
