Rand gains as US growth contracts for second quarter

The dollar pared gains on Thursday after data showed that the US economy contracted again in the second quarter, fueling speculation that the Federal Reserve will not raise rates as high as previously expected.

HEADLINE CPI: The CPI calculates the cost to purchase a fixed basket of goods as a way of determining how much inflation is occurring in the broad economy. The CPI uses a base year and indexes current year prices based on the base year's values.

CORE CPI: The headline figure is not adjusted for seasonality or for the often volatile elements of food and energy prices, which are removed in the Core CPI.
