Chris Griffith resigns as Gold Fields CEO after failed Yamana deal
Gold Fields CEO Chris Griffith has resigned in the wake of the company's
failed bid to acquire Canadian precious metals miner Yamana Gold. Griffith
was appointed CEO in April 2021. He was previously CEO at Anglo
American Platinum and Kumba Iron Ore. Gold Fields South Africa's
executive vice president Martin Preece was appointed interim CEO and will
ioin the board effective 1 January.

HEADLINE CPI: The CPI calculates the cost to purchase a fixed basket of goods as a way of determining how much inflation is occurring in the broad economy. The CPI uses a base year and indexes current year prices based on the base year's values.

CORE CPI: The headline figure is not adjusted for seasonality or for the often volatile elements of food and energy prices, which are removed in the Core CPI.
