Gold Fields sells stake in Northern Star valued at A\$1.1bn

Gold Fields sold a stake in fellow miner Northern Star Resources for A\$1.1 billion (\$725 million), according to people familiar with the matter, asking not to be identified to discuss private information. The company offered about 49.3 million securities in Northern Star at A\$21.85 to A\$22.30 each, according to terms of the deal seen by Bloomberg News on Thursday. That reflected a discount of about 1.6% to 3.6% to its last closing price of A\$22.66. On Friday, a block trade of 47.6 million Northern Star shares, equivalent to 3.3% of the firm's float, traded at 9:38 a.m. Sydney time at A\$22.05 apiece. Northern Star's stock fell as much as 0.8%.
